

PDL BioPharma PRIVACY POLICY

1. INTRODUCTION

This website privacy policy (the “**Privacy Policy**”) describes the types of information PDL BioPharma and its affiliates (together, “**PDL**”, “**we**”, “**our**”, “**us**”) receives about you (“**you**”) when you visit www.pdl.com (the “**Website**”), do business with us, or when you sign up to receive correspondence from us or otherwise communicate with us. It describes what we do with information about you, how we protect it, and how you can contact us if you have a question or concern about the information we hold about you. Your use of this Website is also subject to the Terms of Use available on the Website.

If you have questions about this Privacy Policy, you may contact us using the methods described below in Section 7.

2. INFORMATION WE RECEIVE ABOUT YOU AND HOW WE USE IT

When you visit the Website, you may provide us with certain information about yourself and we will receive other information regarding your use of the Website. We collect, and have collected over the last twelve (12) months, the following information about visitors to the Website:

- (a) Information you may choose to submit to PDL using any means of contact listed on the Website, including the “Contact Us” form and your name, email address and message submitted using such form. In such instances, we will use such information to maintain our business records, manage our relationship with you, communicate with you, and comply with law; and
- (b) Information you submit when you make requests pursuant to Section 5, will be used for the purposes of responding to those requests or as otherwise permitted by law.

When you interact with us outside the context of the Website, including in person, over email and telephone, we may receive certain information about you. We collect, and have collected over the last twelve (12) months, the following information: your name, telephone number, email address, mailing address, employment information and other information you choose to provide when you communicate with us. In such instances, we will use such information to communicate with you, provide you with updates regarding PDL, and as otherwise permitted by law.

We also automatically collect certain information about your interaction with the Website (“**Usage Data**”). To do this, we may use cookies, or other tracking technologies (“**Tracking Technologies**”). Usage data may include: date and time stamps (such as the date and time you first accessed the Website), log data, precise location, and other information regarding your interaction with the Website.

3. WITH WHOM DO WE SHARE INFORMATION COLLECTED ABOUT YOU

We share information collected about you with selected third parties. The categories of recipients include the following:

- (a) Cloud service providers, including Microsoft Cloud Storage;
- (b) Email and communication service providers, including Intrado; and
- (c) Providers of professional advisory services, including consultants, legal advisors and accountants and other third party service providers.

In addition to the above list of recipients, we may also share your information: (i) as required by law, regulation, or legal or judicial process; (ii) in connection with an asset sale, merger, bankruptcy, or other business transaction; (iii) to enforce any applicable terms of service; (iv) to ensure the safety and security of PDL and/or our stockholders; and (v) when you request we share certain information with third parties.

4. DO NOT TRACK SIGNALS AND COOKIES

- 4.1 Do Not Track Signals: “Do not track” signals are preferences that users can set on their web browsers to limit how their activity is tracked across online services. While the Website does not respond to “do not track” signals in your web browser, we do not track the activity of users of the Website across online services and our Website.
- 4.2 Cookies: You may control the way in which your devices permit the use of Tracking Technologies. If you so choose, you may block or delete our cookies from your browser; however, blocking or deleting cookies may cause some aspects of the Website to work incorrectly.

Most browsers accept cookies automatically. However, you may be able to configure your browser settings to use the Website without some cookie functionality. You can delete cookies manually or set your browser to automatically delete cookies on a pre-determined schedule. For example, in the Internet Explorer menu bar, select: Tools →Internet Options→Browsing History→Delete to view manual and automatic options.

5. CALIFORNIA RIGHTS UNDER THE CALIFORNIA CONSUMER PRIVACY ACT

- 5.1 Where applicable, if you are a California resident you may have the following rights under the California Consumer Privacy Act of 2018 (the “CCPA”) in relation to “personal information” we have collected about you as defined in the CCPA; these rights are, to the extent required by the CCPA and subject to verification and any applicable exceptions:
 - (a) *Right to Know/Access*: You have the right to request that we disclose certain information to you about our collection and use of certain personal information about you as described below:

- (i) the specific pieces of personal information collected;
 - (ii) the categories of personal information collected;
 - (iii) the categories of sources from whom the personal information is collected;
 - (iv) the purpose for collecting the personal information; and
 - (v) the categories of third parties with whom we have shared the personal information.
- (b) *Right to Delete:* You have the right to request that we delete the personal information.
- 5.2 To request your exercise of the rights described above, please submit a request to us via one of the contact methods identified below in Section 7.
- 5.3 We do not sell personal information about you.
- 5.4 *Freedom from Discrimination:* You have the right to be free from unlawful discrimination for exercising any of the rights above.
- 5.5 We will need to verify your identity prior to addressing your request.
- 5.6 Only you, or someone legally authorized to act on your behalf, may make a verifiable consumer request related to personal information collected about you. To designate an authorized agent, the authorized agent must provide sufficient information that allows us to reasonably verify that they have been authorized by you to act on their behalf.

6. ACCESS BY PERSONS WITH DISABILITIES

Persons with disabilities who need assistance accessing this Website Privacy Policy may contact us as provided for in Section 12, and depending on your individual needs, we will grant reasonable requests to furnish this policy in an alternative format.

7. HOW WE PROTECT INFORMATION COLLECTED ABOUT YOU

While we maintain certain policies to protect information that we may collect about you, no method of transmission over the Internet is completely secure. Therefore, while we strive to protect information about you that we collect, we cannot guarantee absolute security and confidentiality.

8. THIRD PARTY WEBSITES

This Website may from time to time contain links to other external websites. This Website Privacy Policy does not apply to third-party websites. We do not control and are not responsible for the privacy practices or the content of third-party websites.

9. INTERNATIONAL USERS

The Website is designed for users in the United States only and is not intended for users located outside the United States.

10. UPDATES TO OUR PRIVACY POLICY

We may modify this Privacy Policy from time to time in which case we will update the “Last Updated” date at the top of this Privacy Policy. If we make changes that are material, we will take steps as required by law, including notifying you via the Website and obtaining your consent. The updated Privacy Policy will be effective as of the new “Last Updated” date, or such later date as may be specified in the updated Privacy Policy.
